Village President Update

Here is a summary of the major events that shaped the end of the millennium for the Village of Cleveland. Please note the accomplishments reflect the Village Board's goals of planning, marketing and financing. We understand there are still many things left to do and we will continue to strive to meet your needs.

January—New Burger King opens at 1-43 highway interchange. Debra LaViolette-Spevacek is hired as new village clerk-treasurer.

February—Village secures its first general obligation bond for \$1.25 million to be used for debt reduction and growth.

March—John Kovach Insurance Agency agrees to purchase the old village hall at 1202 W. Washington Ave.

April—Former Cleveland Bank Building is purchased by village for the new village hall. The move is customer oriented and combines community services at one location.

May—Town of Centerville and Village of Cleveland join forces for land use planning. The plan will address issues of urban sprawl, annexations, roads and zoning issues.

June—Dairyland Festival is a big success under the leadership of the Lions Club and the Cleveland Athletic Association.

July—Ground breaking for new Cleveland Medical Center. Brian Reedy is appointed new village police chief. Painted the exterior and interior of the water tower.

August—American Mobile Home Communities submits request for expanding its operations on the north side of Cleveland.

September—Village board approves safety sidewalks.

October—Major street renovation completed for Hazel Street at a cost of approximately \$323,000. Completed the Bouda Platform at Centerville Creek.

November—New medical center opens. Combining under one roof is the Holy Family Medical Clinic and the Veterans Association Clinic. About 1,000 people attend the grand opening.

December—Business survey indicates the community of Cleveland needs a supermarket and can support it. Four people take out nomination papers for three trustee positions on village board.

We have a safe, quiet, friendly place to live. Let's keep it that way.

Clerk-Treasurer Update

The Clerk-Treasurer's office has completed the 1999 tax collection. On February 15 the Village of Cleveland settled with Manitowoc County and the remaining tax bills were given to them for collection. Total taxes collected by the village treasurer were \$872,698.11. Unpaid taxes postponed and delinquent turned over to the county was \$266,779.27. Seventy-seven percent of the total tax roll was collected. Real estate and lottery credits claimed totaled \$71,471.77. Please note that the second payment that is due on July 31, 2000 is to be paid to the Manitowoc County Treasurer.

The Census Bureau will be conducting a census of all village residents. Your participation in the Census is very important to the Village of Cleveland. One of the ways in which the population figures are used is to determine state and federal financial grants and aids to the village. If you would like additional information on the census, log on to www.census.gov. Everyone counts!

Police Department

Since the last newsletter was published the village board has approved some new ordinances.

- At the November, 1999 board meeting the board passed an ordinance to increase the operator's fee from five dollars to twenty dollars per year.
- At the December, 1999 board meeting the board passed an ordinance to increase the fees for dog and kennel licenses. Cost for spayed females or neutered males is five dollars and ten dollars for unspayed and unneutered animals. A kennel license is \$35 up from \$30. A kennel license is required if you have three or more dogs. All dogs in the village must have a license per the ordinance. All dogs must be licensed by April 1.
- The board also passed a resolution to increase the forfeiture from parking violations. The current forfeiture is \$10. The old forfeiture was \$5.
- The board also passed an amendment to the junk vehicles and appliances on private property ordinance.
- The board passed an ordinance to regulate and prohibit the keeping of wolf/dog hybrid animals.

If anyone has any questions regarding these new ordinances please feel free to contact the police department.

After the police department was awarded the Cops More '98 Grant in September, 1999, the police department hired Rhonda Deehr as the police clerk. Rhonda joined the police department on February 1, 2000 and will be working 20 hours a week, Monday through Friday. Her past experience was with the Kiel Police Department for seven years and approximately one year with the Calumet County Sheriff's Department, fulfilling the role of a telecommunication/police clerk. She has an associate degree in Supervisory Management from Lakeshore Technical College. Rhonda lives in Newton with her husband and newborn daughter and will be a big asset to the police department.

On Monday, February 21, Jeffrey Vogt from Manitowoc will join the police department as a full-time officer, he is replacing Officer Benzschawel. Officer Vogt has the experience and knowledge of a small town police department. He graduated from the police science program at Lakeshore Technical College in May, 1996. Officer Vogt has approximately three years experience with the Valders Police Department and a little over a year experience with the Kiel Police Department. The March Neighborhood Watch Meeting will be March 15, at 7 p.m. This would be a great opportunity to meet Officer Vogt

What the village board is trying to accomplish is timely payment of the sewer and water bills. It costs the utilities an unnecessary expense to pursue delinquent customers. So please, plan ahead and pay your sewer/water bill on time.

The village board has approved implementation of a forest management plan for the former Henley property at Veterans Park and the pine plantation at the wastewater plant. Work on this plan will start sometime in March. There will be opportunities for public input during the planning process through public informational meetings. Please attend if you are interested.

Plans for the new hardball field concession stand and bleachers are nearing completion. Construction of these new facilities is expected to begin in late summer. These new facilities will be a great addition to Veterans Park.

The Parks Department has received a grant of \$2,000 from Forward Endowment. It will be used to extend the Bouda Platform. During the next several months a Forest Management project will begin on the Henley Park property and the wastewater treatment area. Peter Wagner from Valders has been hired to oversee the project. He will be writing a plan and the parks board will hold public meetings so that everyone can be informed. It is a very large concern to save as many trees as possible. These trees need to be thinned before a fire or disease would take them all. Watch for announcements concerning this project so that you may participate in the discussions

Joint Plan Update

The Joint Plan Committee of Cleveland and Centerville has been meeting diligently coming up with a land use plan for public comment. The purpose of the land use plan is to provide a plan that describes how development will look and what types of activities are allowed. This will serve as the primary public policy document for guiding future growth and development in the village and town. The plan incorporates many goals of preservation and planned growth:

- Preserve the shoreline, water features and other natural amenities
- Preserve agricultural land
- Retain existing rural character
- Preserve historical structures and sites
- Plan for high quality, low density residential development near existing infrastructure
- Plan for commercial development at major transportation routes and near existing infrastructure

The plan defines a number of land use districts, and then looks at Cleveland and Centerville together in defining district boundaries. Cleveland and Centerville have worked closely together creating land use districts that are acceptable to both places. The proposed land use districts are:

- 1. Environmental Preservation
- 2. Agricultural Preservation/Rural Residential
- 3. Village Center
- 4. Roadside Mixed-use
- 5. Neighborhood Residential
- 6. Neighborhood Mixed-Use
- 7. Open Space Residential
- 8. Shoreline Residential
- 9. Historic Overlay

Each district has defined development policies. It is the intention of the town and village to amend our ordinances so that they are consistent with the land-use districts defined in the Joint Plan.

The committee is eager to have public input. A public hearing will be scheduled before the Village and Town Plan Commissions and Boards meet to discuss adoption of the plan. A public workshop was held in April, 1999, and the Committee has tried to incorporate the concerns expressed there. If you have ideas or concerns about the future of our community, please let us know. Committee members are: Jerry Heimerl, Brian Kraemer, Ed Thompson, John Kirsch and Judith Perlman.
