## Village of Cleveland Year 2005 Budget

The Village Board of Cleveland approved the following budget after a public hearing on November 16, 2004. **The levy represents a** <u>0.0%</u> **change from the 2003 Payable 2004 tax rate of \$6.64/\$1000.** Copies of the detailed budget are available for inspection in the Clerk's Office at Village Hall.

In 2004, the Village completed acquisition of a lakeshore property adjacent to and directly north of the Village-owned parcel containing the mu-

nicipal garage facilities. The purchase price was funded entirely by grants and donations. In 2005, the Village anticipates undertaking the reconstruction of Elm Street; and funding the project with \$50,000 already in reserve, \$290,000 in borrowed funds, and special assessments.

### **Cleveland School**

One of the great advantages of Cleveland being a part of the Sheboygan Area School District is the fact that we are able to offer a small school education with the variety of offerings of a large school district. Centreville Settlement, Inc., is a nonprofit organization dedicated to the preservation of rural heritage in the Centreville Area.

The Lutze Housebarn is a unique structure, and is heralded across the nation as an outstanding example of Saxon German architecture from the 1850s. Since 1992, steadfast volunteers have provided talents in woodworking, stone masonry, hole digging, landscaping, cleaning artifacts, old-fashioned cooking, while enjoying the old-time fellowship of working together outside for a common agrarian project.

The workdays are open to all—young and old—and will begin again in April 2005 after the 2004 series of 18 workdays. The next event is the traditional holiday dinner scheduled for Monday, Dec. 6, at Wilderness Roadside Inn in Plymouth at 6 p.m. For a reservation, call Kathy Pearce at 451-1134 or Chris Kuehnel at 693-3141. Upcoming events include hands-on restoration clinics on timber frame repair, stone masonry, and fachwerk (the art of clay and straw mixed together to insulate the outside of the structure.) In addition, siding installation, window replacement and interior room artifact arrangements are on the exciting calendar of events for the coming historical year. Over the past 12 years at the Lutze Housebarn, nearly 17,000 hours of volunteer time have helped it remain one of the premiere historical hands-on restoration sites in the country. Tours are available on workdays from 10 a.m. to noon. Call in advance to schedule group tours.

Centreville Settlement, Inc., continues to keep Cleveland and the surrounding area in the historical limelight with articles in national-level journals, public television documentaries and representation by members on boards of the state historic organizations.



## **Hello Gardeners!**

'Tis the season to get those great gifts for the gardener in your house.

If you want to keep them happy, get them their very own potting bench with a removable bin in the bench surface to hold potting soil, below-counter shelving and upper shelving to hold pots and small hand tools. Give the countertop a raised one and one-half inch molding on three sides to hold the soil from spilling off, and you've got the Cadillac of potting benches. (Can holders are optional.)

## Cleveland Fire Department Budget Increase

Due to rising cost of equipment, fuel and repairs, the Cleveland Fire Department found it necessary to raise the Fire Department budget by 21 percent over last year. The cost of fire apparatus has been going up at 14 percent the last few years.

The portion for the Village of Cleveland will be \$59,674. This covers the cost of personal protective equipment for 31 fire fighters, 14 First Responders, six trucks, one building, and all equipment on the trucks. The cost to provide gear and equipment for one fire fighter is \$3,400. This includes boots, pants, coats, gloves, Nomax hood,

This will cost each person in the village \$39.55 per year for fire protection and First Responder services. The fire fighters and First Responders are on call 24 hours a day, seven days a week and 365 days a year. Please feel free to contact me with any questions at 693-8810.

There is free mulch available to village residents. The mulch is located at the west end of Whitetail Lane, which goes past the wastewater plant. The mulch is composed of last year's yard waste, which is ground up, piled and decomposed. The yard waste collected this year will be ground up this December and will be available for use next spring. The mulch is very good gardening material and residents are welcome to take it.

If you are hauling yard waste to the yard waste site, please unload the material **on** the large pile directly west of the driveway. Do not unload in the middle of the yard as this creates a lot of unnecessary work pushing it onto the pile. Thanks for your cooperation.

Winter parking regulations will be in effect from December 1 through March 31 to help facilitate snow removal. There is no parking on the village streets between the hours of 1 a.m. and 6 a.m. during this time period.

Residents are reminded to clear the snow away from fire hydrants this winter. This small chore could make the difference in saving a life in case there is a fire.

Residents are reminded that waste oil is not picked up by the curb and has not been for the last three and one-half years. Waste oil will be accepted during Manitowoc County's Clean Sweep Program which will be held on May 14, 2005, at Manitowoc County Expo Center. Please dispose of your waste oil in an environmentally safe manner.

There will be a major street construction project happening next year. Elm Street, East Madison Avenue and East Grant Avenue from Elm Street to Forest Street will be reconstructed. New storm sewer, curb and gutter, and new asphalt will be installed. Please be patient during the construction phase.

## 2004 Lottery Credit

You may claim the 2004 lottery credit if, on January 1, 2004, you owned your primary residence, which is defined as either (1) the place where you live most of the time or (2) the home to which you intend to return if you are temporarily away. You can have only one primary residence. Mobile home owners in the village may also qualify for the lottery credit.

If you received the lottery credit last year and have not changed your primary residence, you do not need to apply for the credit again.

If you acquired your residence after January 1,

2004, AND it was the primary residence of the previous owner on January 1, 2004, you can qualify for the lottery credit. You will need to supply the name of the seller for verification of ownership.

Please contact the clerk-treasurer's office at 693-8181 if you wish to apply for the lottery credit. The lottery credit paperwork can be filed in the Clerk's office until January 31, 2005; after that, it must be filed with the Manitowoc County Treasurer. You are encouraged to file before you pay your 2004 property taxes.

## **Police Department**

After nearly a year of planning, the Cleveland Police Department assisted the Sheboygan County Sheriff's Department and Wisconsin State Patrol in implementing traffic control for the Professional Golfers Association's championship held at Whistling Straits in Haven during the week of August 8, 2004.
